4. First-aid measures

11. Toxicological Information

Acute Toxicity - Oral	LD50 (rat) 1995 mg/kg for sodium laureth sulfate
Ingestion	Ingestion of the concentrate in relatively large amounts can result in headache, nausea, lethargy, motor weakness and incoordination. If aspirated into the lung, e.g. from vomiting, the presence of surfactants may result in chemical pneumonitis or other lung damage.
Inhalation	The components of the product are of low volatility and no adverse effects are expected from handling the concentrate. However, care should be taken to avoid the inhalation of excessive amounts of spray mist during field spraying, respiratory irritation may occur.
Skin	Prolonged contact with the concentrate may cause irritation. Prolonged contact with the concentrate can cause defatting of the skin and may result in dermatitis. Prolonged contact with the concentrate may result in absorption of butyl diglycol in harmful amounts.

Container Disposal	Triple or preferably pressure rinse containers before disposal. Add rinsings to the spray tank. Break, crush or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt. drumMUSTER is the national program for the collection and recycling of empty, cleaned, non returnable crop production and on-farm animal health
