DIRECTIONS FOR USE:

Application Rate: Apply at 250 kg per hectare.

Apply to dry turf or foliage and irrigate thoroughly immediately after application. Iron and other plant nutrients can cause staining of sidewalks. Sweep walkways prior to irrigation. Walkways should be dry at time of application. Keep away from pools, ponds, etc. Do not contaminate potable water. Do not apply with a drop-type spreader. The grinding action of these spreaders destroys the coating of the urea and will increase burn potential.

- Controlled long-term nitrogen release for uniform growth.
- Good initial green-up without surge growth.
- Minimizes excessive nutrient release at high temperatures.
