2. HAZARDS IDENTIFICATION

Hazardous Nature:

4 . FIRST AID MEASURES

Inhalation:

If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Seek medical attention if breathing problems develop.

Skin Contact:

In case of skin contact, immediately remove contaminated clothing and wash affected areas with water and soap. Seek medical attention if symptoms occur.

Eye Contact:

In case of eye contact, hold eyelids open and flush eye continuously with large amounts of water for at least 15 minutes. Seek medical attention if symptoms occur.

Ingestion:

If swallowed, do not induce vomiting. Rinse out mouth and give some water to drink. Do not give anything by mouth to an unconscious person. Seek immediate medical attention.

6 . ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment and Emergency Procedures:

Wear approved self-contained breathing apparatus and full protective clothing. Evacuate all non-essential personnel from affected area. Do not breathe vapours. Ensure adequate ventilation. Extinguish all sources of ignition. Avoid sparks and open flames. No smoking.

Environmental Precautions:

In the event of a major spill, prevent spillage from entering drains or water courses.

Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and absorb spill with sand, earth, vermiculite or some other absorbent material. If spill is too large or absorbent material is not available create a dyke to stop the spill from spreading. Collect the spilled material and place into a suitable container for disposal. Wash area after spills.

Precautions for Safe Handling:
